NATIONAL AMERICAN MISS / ALL-AMERICAN MISS / INTERNATIONAL JUNIOR MISS 2021 FORD MUSTANG DRAWING RULES

- GENERAL CONDITIONS:** National American Miss, Inc. (Sponsor) is the Sponsor of the National American Miss 2021 Ford Mustang Drawing (Drawing). The Drawing is open to "Nationals Participants" (including International participants) in the 2021 National American Miss / All-American Miss / International Junior Miss pageant Finals in Orlando, Florida (Nationals Participants). By entering, you agree that you have complied with and will be bound by these official Drawing Rules (Drawing Rules). - TO ENTER:** Nationals Participants are entered in the drawing as they arrive at the ballroom and check in for the Drawing on Thanksgiving Day 2021. The time of the check-in and drawing are shown in writing on the final schedule that is mailed to all registered Nationals Participants prior to the event. - SELECTION OF WINNER:** The Winner will be chosen in a random drawing by Sponsor at 2021 Finals on Thanksgiving Day, November 25, 2021 in Orlando, Florida at the Hyatt Regency Orlando. Winner will be notified at the time of the drawing.
- PRIZE: There will be only one Winner of one Prize.** The randomly-selected Nationals Participant will be given one prize of a 2021 Ford Mustang Fastback (basic model) three year lease. The prize is comprised of the 36 monthly lease payments.
